

MEMORANDUM OF UNDERSTANDING
IN RESPECT OF
THE DISCIPLINE SHOWJUMPING

Between

SOUTH AFRICAN NATIONAL EQUESTRIAN SCHOOLS ASSOCIATION
("SANESA")

and

SOUTH AFRICAN SHOW JUMPING
(SASJ)

PREAMBLE:

In the interest of re-establishing a positive and mutually beneficial relationship between SANESA and the Discipline Association, and in the interest of developing the discipline of Jumping within the SANESA Interschools Equestrian League throughout the Republic of South Africa, for the benefit of both SANESA, SASJ and all of the show jumpers participating in SANESA shows, the parties agree to enter into this Memorandum of Understanding.

NOW THEREFORE THE PARTIES AGREE:

1. SASJ shall, upon the signature hereof, present this Memorandum to each of their Provincial Structures throughout the Republic of South Africa, which shall indicate, in writing, their acceptance and adoption hereof within their particular Province, and upon the acceptance hereof, shall co-operate with the SANESA structure within their Province in accordance with the terms of this Agreement.
2. SASJ shall recognise and award Qualification points (QR) in respect of all SANESA jumping classes within the Province, subject to the following:
 - 2.1 any SANESA rider requiring grading points shall be registered with SASJ, as per Discipline Association requirements;
 - 2.2 the horse upon which the rider wishes to obtain Qualification points must, likewise, be correctly registered with SASJ, and Compete in the Grade they are qualified to compete in, as per the Discipline Association requirements;
 - 2.3 the venue at which SANESA holds its shows, and for which the rider is seeking Qualification points, must be an approved venue in terms of the Discipline Associations requirements;
 - 2.4 the judges judging any such classes shall be properly qualified in terms of the Discipline Associations requirements to judge at the requisite level;



- 2.5 This grading levy will be R15.00 per class (vat exclusive).
3. The Rider shall only qualify for Qualification points at the level they are appropriately registered with the Discipline Association;
 4. In the event that a venue is not approved by the Discipline Association, SANESA shall work together with the Discipline Association and the venue owners to achieve the necessary approvals;
 5. The SANESA Rider shall be required to register on the SANESA system with his/her Discipline Association Registration Number, and when entering a show shall select the option for Qualification points;
 6. Provided the SANESA show meets the requirements as set out above, and the Rider has registered correctly, the Discipline Association shall grant the appropriate Qualification points to the rider for grading and other appropriate Discipline Association awards upon completion of the relevant class, upon the recording of the relevant scoring for the class.
 7. SANESA shall, upon the Rider's entry for the class, and selection for grading points, collect the requisite grading levy for the appropriate level, which SANESA shall pay across to the Discipline Association by no later than the last working day of the month immediately following the receipt of an invoice from the Discipline Association, which SANESA shall be entitled to first reconcile against the grading levies received, and following the due reconciliation SANESA shall deposit into the Discipline Association's bank account, as set out on the invoice.
 8. SANESA shall present the Discipline Association in an electronic format, with the relevant riders' score sheets as well as supply a copy of the score sheet duly signed by the presiding judge, as evidence of the results of the class, for the purposes of the issue of the grading points.
 9. In the event that the rider fails to pay the requisite grading levy to SANESA, then SANESA shall advise the Discipline Association accordingly, and the Qualification points shall be withheld until such time as the grading levy is paid.
 10. The Discipline Association undertakes to allocate the Qualification points immediately upon receipt of payment of the grading levy in respect of the rider, and in any event not more than 7 (seven) days thereafter, subject only to clause 8 above.
 11. The Discipline Association undertakes to send any changes to the Discipline Rules and Regulations to info@sanesa.co.za as well as the SANESA National Representative of the discipline in time to allow for riders to prepare for these changes before the next event.



12. The Discipline Association and SANESA agree on the following acceptable dispensations to be granted for all SANESA classes:
- 11.1 The accommodation of the SANESA dress code which includes the wearing of school colours, school shirts, school numnahs, school blazers and school tracksuit tops; it being specifically recorded that issues such as horse equipment such as bits, whips etc shall be in accordance with the Discipline Association rules;
- 11.2 The parties agree that these dispensations shall be recorded in writing, and shall be published by SANESA on its website, and may be amended from time to time by agreement between the parties. The first dispensation document is attached hereto, marked Annexure "A".
13. SANESA shall work together with the Discipline Association in order to provide the opportunity for judges and officials to train and develop their skills within the SANESA environment.
14. SANESA shall provide the opportunity to, within the constraints of the SANESA Constitution, to provide the Discipline Association with the opportunity of marketing the discipline to its riders, in order to promote the discipline of Show Jumping within the SANESA structures.
15. On all payment requisitions, the Discipline Association will provide SANESA with a copy of the original invoice from the service provider.
16. The continued relationship between SANESA and the Discipline Association is dependent on an open, transparent and accountable basis.
17. SANESA will pay over R1.00 per entry to the Discipline Association for development.

ANNEXURE "A"

JUMPING DISCIPLINE SPECIFIC RULES AND REGULATIONS 2020

Although SANESA will endeavor to adhere to all SAEF Technical Discipline Rules including special dispensations noted in this document, SANESA Rules and Regulations will be final.

1 SHOW JUMPING

1.1 SANESA JUMPING RULES

Jumping Rules as per SASJ National Technical Discipline committee rules, including/excluding the following:

- 1) No Level 0 Lead Reins may compete in Jumping classes.
- 2) Level 0 off lead may compete in Jumping.
- 3) There may be no cross entry of horse-rider combination between levels at any one show.
- 4) No horse or pony may do more than 2 show jumping classes per day.
- 5) All ponies/horses in Jumping are to be clean and neatly turned out.
- 6) Jumping classes to consist any one of the following:
 - Normal Competition (FEI Art. 238.2.2)
 - Ideal time (please consult schedule for description)
 - Accumulator (FEI Art. 269.5) (8 fences with a joker – 1 round against the clock)
 - 2 Phase (FEI Article 273.1.5.3.)
 - A2 (FEI Art 238.2.1)
 - Competition 238.2.1 (no jump off for level 0 riders)
- 7) All schedules shall include the SANESA Competition and a choice of one of the other classes mentioned in point 6 above for the second class.
- 8) All team selection for National Teams, if and when applicable, will be from the SANESA Competition class.
- 9) The onus is on the rider to ensure that he/she and his/her horse/pony are correctly registered and have entered in the correct classes to be considered for grading points. It is on the onus of the rider/parent to submit results to the relevant discipline structure.

1.2 JUMPING DISPENSATIONS GIVEN TO SANESA:

- 1) Horses and ponies may compete together in all classes.
- 2) A horse or pony may compete in the same class with two different riders.
- 3) Learner judges may judge all non-graded classes.



1.3 PRIMARY SCHOOLS JUMPING LEAGUE

1) Newcomers' Challenge Classes

Level 0 – Off Lead: 40cm courses (8 jumps only, simplistic course with minimum fillers, no combination)

NO Lead Reins may compete in this class

2) Normal League Classes

Level 1: 50cm courses (max of 10 jumps, simplistic course with minimum fillers)

Level 2: 60cm courses (normal course and equipment, excluding water tray)

Level 3: 70cm courses (normal course and equipment, excluding water tray)

Level 4: 80cm courses (normal course and equipment, excluding water tray)

Level 5: 90cm courses

Level 6: 100cm courses

Level 7: 110cm courses

1.4 HIGH SCHOOL JUMPING LEAGUE

1) Newcomers' Challenge Classes

Level 0: 60cm courses (8 jumps only, simplistic course with minimum fillers)

2) Normal League Classes

Level 1: 70cm courses (max of 10 jumps, simplistic course with minimum fillers)

Level 2: 80cm courses (normal course and equipment, excluding water tray)

Level 3: 90cm courses (normal course and equipment, excluding water tray)

Level 4: 100cm courses

Level 5: 110cm courses

Level 6: 120cm courses

Level 7: 130cm courses
