IMPORTANT INFO TO NOTE FROM THE CHECKLIST:

- 1: Levies will not be able to exceed 50% of the total entry fee. (This will be enforced)
- 2: SASJ will in its sole discretion award the events to an Organizing Committee (OC) and reserves the right to award the event for an extended period of time or a fixed term, based on performance and meeting the criteria
- 3. If /when awarded an event the OC will be required to sign the 2019 SASJ Service Level agreement.
- 4. The OC will adhere to the appointment procedures for all officials who must be approved by the SASJ office before being appointed.
- 5. Levies will be applicable as per the 2019 SASJ Levy Document
- 6. No Junior or Pony classes may be held at National events in the main arena unless they have their own National classes and title event.
- 7. No Junior or Pony classes may be held at FEI events at the same venue of the same time period.
- 8. The OC needs to appoint a Show Secretary who will always be at the show admin office during the show this needs to be a knowledgeable person who has run shows before.
- 9. Jump Equipment needs to be of FEI standard for National and FEI Events, not old equipment from previous provincial bodies, with heavy poles.
- 10. Stables, Ablutions, Grooms facilities need to be of a good high standard for a National and FEI Event.
- 11. No horse may compete in more than 2 classes per day.
- 12. Total Prize money for all levels must be greater than R65000.
 - * Minimum prize money for 1.50m classes must be R5000 for the 1st class, R10, 000 for the 2nd class and R30, 000 for the titled class.
- 13. 15% of prize money will be deducted for the SASJ Jumping fund for all National Open classes
- 14. Prizegiving's, Podiums, Day Blankets, Sashes, Rosettes need to be awarded and of the quality for the stature of a National/International event and have all the razzmatazz.
- 15. All applications must have the permission and documentation required by their relevant municipalities
- 16. No Bought entries are allowed at National shows.
- 17. Electronic Timing is required for all National classes TAG timing is required for all FEI Events and must be booked and hired from SASJ with the approved TAG Timing operator.
- 18. Grooms ablutions need to be of a standard for top events.
- 19. Ablutions need to fit the requirements for the number of people expected at the event.
- 20. Catering facilities on offer need also to be suitable for the number of people expected at the event.
- 21. Security and Parking are all to be of the standard and meet the requirements of the Municipality for Events open to the public.
- 22. FEI = We urge Organising Committees to bear in mind, when establishing the competition schedule, that a groom's work day starts well before the first competition and ends long after the last competition of the day. Every effort should be made to provide equitable working conditions for the grooms
