Olympic Games – team qualifications

The Pan American Games 2023, which finished in Santiago (CHI) on 5 November, were the final event for equestrian team qualifications in view of the Paris 2024 Olympic Games.

No less than 23 nations from five continents have qualified at least one team for the Olympic equestrian events, which will be held from 26 July to 6 August 2024 in Versailles.

These nations are: France (as the host nation), Australia, Austria, Belgium, Brazil, Canada, Denmark, Germany, Great Britain, Ireland, Israel, Italy, Japan, Mexico, Kingdom of Saudi

Arabia, New Zealand, Poland, Sweden, Switzerland, Spain, The Netherlands, United Arab Emirates, and the United States of America.

Some 11 National Olympic Committees, including France as the host nation, will be represented by teams in each of the three equestrian disciplines, as follows: France, Australia, Belgium, Brazil, Canada, Germany, Great Britain, Poland, Sweden, The Netherlands, and the United States of America.

Twenty nations have qualified teams in Jumping, 14 in Dressage, and 16 in Eventing. The 15th team slot in Dressage, meant for Olympic Group F (Africa & Middle East), will be re-allocated as per paragraph F (Reallocation of Unused Quota), article 1.5 (Composite Teams) of the Dressage Qualification System, which states:

1.5 Composite Team (see also the Appendix): A three (3) member team from an NOC. The Composite Team will be selected according to the following process:

(i) the respective rankings of each NOC's top three (3) different Athletes in the FEI Olympic Ranking - Dressage shall be added together to give an aggregate ranking;

(ii) the NOC with the best aggregate ranking shall be awarded the redistributed quota place;

(iii) in the event of a tie (i.e., where the aggregate rankings are the same), the redistributed quota place shall be awarded to the NOC with the highest ranked Athlete on the FEI Olympic Ranking - Dressage. In the event of a further tie, the redistributed quota place shall be awarded to the NOC with the second highest ranked Athlete on the FEI Olympic Ranking - Dressage, and so on. If the tie cannot be broken following this process, the FEI will invite the NOCs/NFs concerned to a draw.

Additional "composite" teams in Dressage and Eventing may be formed on the basis of the Olympic rankings, should the reallocation procedure be used.

Olympic Games – individual qualifications

The Pan American Games 2023 were also used for individual qualification in Olympic Groups D (North America) and E (Central and South America) in Jumping and Dressage.

In Jumping, Argentina, Chile, and Colombia and in Dressage, Chile and Ecuador qualified one individual athlete each.

Individual qualifications, be based on the FEI Olympic rankings, are ongoing.

Paralympic Games – team qualifications

In Para Dressage, 9 nations have obtained four qualification slots each for their National Paralympic Committee. These teams are: France (as host nation), Belgium, Denmark, Germany, Great Britain, Italy, The Netherlands, Sweden, and the USA.

Team qualifications through the FEI Para Equestrian Regional Team Ranking Allocation, and the FEI Para Equestrian Team Ranking List Allocation as well individual qualifications through the Para Equestrian Individual Ranking List Allocation – Regional Distribution and the Bipartite Commission Invitation Allocation continue.

Paralympic Games – key qualification deadlines
Athletes have until **31 December 2023** to attain performances to be recorded on the FEI Paralympic Team and Individual Ranking Lists.

The process of allocating the qualification slots will begin on **4 March 2024** when the FEI will notify the National Paralympic Committees of the number of allocated slots.

Athletes have until **19 June 2024** to attain a Minimum Eligibility Score, which is also the nominated entries date.

The Bipartite Commission Invitation application process will start on **19 February 2024**.

Equine Prohibited Substances

We are pleased to inform you that the FEI has published an online course regarding Equine Prohibited Substances on FEI Campus.

The course is suitable for all members of the equestrian community, regardless of their role and has been designed to provide practical advice. It explains how to determine whether a substance can be used at FEI Events, how to treat horses while staying within the rules, as well as how to avoid inadvertent contamination.

EVENTING UPDATES

Frangible Devices

Below you will find the updates applicable as of 1 January 2024.

We are aware that a certain time period is required by Course Designers and Course Builders, to work on building new frangible devices and to incorporate designs into more traditional type jumps which fit the MIM instruction weights and dimensions. We also understand that it is time consuming and costly to update existing frangible fences, therefore:

► As of **1 January 2024**, all newly built fences must comply with the new requirements, however, to help with the inherent inaccuracy of building fences in the field, a margin of up to 25% over the maximum weight has been included in the MIM Instructions.

All new MIM fences must be fitted with a **MIM weight plate as of 1 January 2024 latest** (available from MIM <https://mimclip.mimsafe.com/shop/> at no charge and now supplied with all new kits) at time of building.

► All existing MIM frangible fences built **prior to 1 January 2024** may stay in use without changes for the duration of their lifetime use.

Eventing horse fall recommendation 2024

The Eventing Committee and Risk Management Steering Group have agreed to include the following recommendation for implementation by Ground Jury as of 2024:

Following any Horse Fall on Cross Country, a systematic interview/discussion will be held between the Athlete and the Ground Jury (President or Member) and/or the Technical Delegate. The aim is educational in order to better understand the circumstances and to learn for the future – Horse falls are a serious risk factor in our sport and need to be minimised. The discussion is to be recorded in the Judge and/or TD report (a section will be added in the reports).

Online FEI Eventing and National Safety Officer (NSO) seminar 2024

The Online Eventing Seminar and NSO Seminar will be held on **Saturday 20 January 2024**, for all Eventing Officials, Eventing FEI Athletes, National Federations, NSOs, Course Builders, etc.

The Online NSO Seminar will be held on **Sunday 21 January 2024** for NSOs and NFs. More information will be communicated in due course.

FEI CLEAN SPORT - EQUINE ANTI-DOPING UPDATE

We would like to inform our community that from 1 January 2024, the FEI will introduce a new sampling kit used in the collection of Equine Anti-Doping and Controlled Medication samples at events.

The new sampling kits will be provided by [LockCon](#), a Swiss company led by industry specialists who have introduced the latest standards and technologies to sample collection. A transition period will take place during 2024, where both the current Berlinger and Australian Racing sampling kits will be used alongside LockCon kits. Berlinger and Australian Racing sampling kits will no longer be used at FEI events from 1 January 2025.

The FEI will provide further information to all the different stakeholder groups in the coming months to ensure a smooth transition period.

HUMAN ANTI-DOPING

ITA (International Testing Agency) November 2023 webinar: "What you need to know for 2024".

The World Anti-doping Agency (WADA) Prohibited List for 2024, which documents all substances and methods prohibited in sport, has recently been published and its changes will

come into force on 1 January 2024. Mark Stuart, a sports pharmacist, and ITA Operations Development Senior Manager will be explaining the key changes athletes and Athlete Support Personnel must be aware of.

Alongside the changes to the Prohibited List, David Healy, World Anti-Doping Agency (WADA) Senior Manager, Medical, Science and Medicine, will be providing a reminder on Therapeutic Use Exemptions (TUEs), and we will introduce the recently launched ITA TUE Assistant online tool.

We strongly encourage athletes and athlete support personnel to attend this webinar, which will be delivered in English with simultaneous translation to four additional languages – Arabic (العربية), Spanish (español), French (français) and Russian (русский). Please register via the following link:
