1. Membership Fees 2020

- No differential applied for FEI and non-FEI everyone is a SAEF Member.
- Basis for this is that all international affiliation fees will be paid by SAEF and there are benefits already being provided by FEI to non-FEI Disciplines. (Exception is POLO whose International affiliation fee is R93000 - and in relation to number of members, a contribution of R25000- is considered appropriate.)
