Transformation & Development Plan - General

- 1. The plan will run from 01 January 2015 31 December 2015.
- 2. The plan will be reviewed annually.

Guidelines

- 1. There will be no cost for T&D horses and riders to register with the SAEF.
- 2. There will be no cost for T&D horses and riders to register with SASJ.
- 3. The EDS Levy received from entries, will be used for Training Days at Shows, Clinics with SJ Coaches, Seminars etc for TD Riders

Criteria for acceptance onto the TD Plan

- 1. Must be a South African citizen
- 2. Must be a member of a previously disadvantaged population group
- 3. Must have a gross monthly income of R6 000 or less
- 4. Must have a dedicated horse to ride must jump the same horse at shows
- 5. Cannot be sponsored, and may not ride the TD horse at shows with a sponsor's saddlecloth
- 6. Must have a mentor
- 7. Must complete the TD Registration Form and be accepted/approved by SASJ in writing and on the SASJ system.
- 8. Age Limit under 50 years old
- 9. Subject to Annual Evaluation and Annual Re-application.

Show Entries

- 1. SASJ will pay entries for 1.30 and above for one horse per TD Rider
- 2. Show Entries 1.20 and below Show Holding Bodies may, at their discretion, waive entry fees, and in turn, SASJ will waive Levies (but only for approved TD riders registered on a national list with SASJ.). SASJ is not able to pay entry fees.
