



## NOMINATION AND VOTING PROCESS FOR THE NATIONAL ELECTIONS FOR SOUTH AFRICA SHOWJUMPING AGM on the 16th March 2020

## SASJ National Election Process – 2020

- Every Member in Good standing with a club and Province and in Good Standing & Registered with SASJ may nominate a candidate who is in good standing with his/her club, SAEF and SASJ (Over the Age of 18) for any position available on the SASJ National Committee.
- 2) Such nominated person can be nominated for more than one position. Should a person nominated be elected for the highest position all other positions fall away. Should he/she not be elected for the highest position nominated for election such a member continues down the line of nominated positions.
- 3) Notice shall include the call for nominations of the positions needing to be filled.
- 4) Nomination forms are collected by the Provincial SASJ Committee from SASJ Clubs submitting nominations, all correspondence to be copied to SASJ National Office and the electoral officer. The Provincial SASJ Committee decides who is best suited and only one nomination for each position is processed.
- 5) All nomination forms must be signed off by either the Provincial SASJ President, Provincial SASJ Vice President or Provincial SASJ Secretary in the nomination and seconding signature positions. The nominee must also sign the form accepting the nomination. The Provincial SJ President/Committee submit only 1 nomination for each position within 30 days (in this case on or before the 29th February 2020) to the National SASJ Office (tiffany@sashowjumping.co.za) with a copy to the SAEF Electoral Officer in this case Mr. Wessel Strauss sg@saef.org.za

## **NOMINATION PROCESS TIMELINES**

- I. Notice shall be given no less than **60 Days (Sixty)** before the date of the meeting.
- II. Notification shall be sent to every SASJ provincial Committee and SASJ Exco informing them of the date, time and venue of the meeting and who the SAEF Electoral Officer will be.
- III. Notice shall include the call for nominations of the positions needing to be filled. Completed nominations forms as in Item 5 shall be forwarded to the SAEF Electoral officer no less than 30 (thirty) days from the receipt of the nomination forms.
  - \*Nomination forms are to be sent by any club to their relevant SASJ PROVINCIAL PRESIDENT. The relevant SASJ Provincial Committee will submit nominations no less than **30 days** to the SASJ National Office with a copy to the SAEF Election Officer.
- IV. No less than <u>25 (twenty-Five) days</u> from receipt of the nomination forms The National SASJ Office after verification with the SAEF Electoral Officer will distribute amongst the Provincial SASJ Presidents the list of nominated candidates.
- V. Only Provincial SASJ Presidents may cast a vote in terms of their Provincial Mandate on Election Day with the understanding that a quorum of 50% plus one of Total Provinces shall be present. Majority votes recorded shall establish the elected person.
