CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in International Equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses' welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and Athletes must be fit, competent and in good health, before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the Event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper Veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

Except in circumstances where special dispensation has been obtained from the Show Director, competitors must take part in any parade, display or Prize giving. Failure to do so may result in forfeiture of any Prize money, Ranking/Qualification Rounds and/or Trophies.

LEVIES: Levies included in Entry Fees per class

TEMPORARYThere will be a **temporary membership fee of R330 per rider** for the duration of the event for**MEMBERSHIP:**competitors who are not members of Durban Shongweni Club.

RESTRICTIONS: No rider may compete on more than <u>3 horses in any class</u>, apart from the 2019 S. A. Adult Show Jumping Championships, where they may only ride two horses.

OPEN SECTION: Horse and Rider combinations are restricted to 1 class per day with a maximum of 4 classes at the event. Or a maximum of 2 classes per day with a maximum of 3 rounds as the programme may necessitate in the Debutante arena.

All entries will be restricted to the number of rounds per day per arena.

THERE WILL BE NO UPWARDS MOVEMENT OF ENTRIES (horses) BETWEEN THE JANE LATIMER (A) AND DEBUTANTE ARENA (B). We will allow a 1.20 horse to move down to the 1.10m but you will then have to stay in the 1.10 classes for the duration of the show.

Recommended rounds per day will be in consultation with the President of the Ground Jury, SASJ Representative and Athletes Representative.

In conjunction with the President of the ground jury and the SASJ technical delegate, the OC reserves the right to cancel, combine, limit or divide classes or change arenas if deemed necessary and it is the competitors responsibility to check the programme on the website, ensure that their email address is up to date and to read emails and newsflashes pertaining to the show.

Should your entry be deleted for non-payment, the entry will not be restored based on when it was initially done but will be based on when it was paid for thus if the arenas are full it will be added to the waiting list.

<u>Should</u> the show be oversubscribed the OC in conjunction with the PGJ <u>may</u> take Adult entries before J/A Spec Riders and Adult Horses having obtained 2 QR's in 2019 at the entered grade will be taken first excluding Team horses.

CLARIFICATION on WHO CAN ENTER SA CHAMPIONSHIPS

A rider with J/A SPEC Registration can compete in both SA Adult Champs and Junior Champs on the same horse. They just cannot ride Junior 1.30/1.35 and Adult 1.50 Classes as these are the National Championship Classes.

A rider can only compete in either Junior Teams or Adult Teams at all levels in one Calendar Year – not both as these are also National titles.

It was agreed that we cannot discriminate towards a rider with only one horse as we need to grow our sport.

A rider can compete a Pony in SA Pony Rider Championships and a Horse in either Children or Junior SA Championships (Not both).

REFUNDS: Entries will not be refunded if withdrawn after closing date of entries.

NOMINATIONS:

Declarations for 1.30m, 1.35m, 1.40m & 1.50m classes taking place on the first day must be made in writing by no later than 12h00 on Monday, 5th August 2019 Riders must each day declare which height their horses will compete (1.50m+, 1.40m, 1.35m, 1.30m.

YOU MAY NOT DO YOUR NOMINATIONS DURING HORSE INSPECTION.

Declarations will close 30 min after the end of the last open class on each day.

Riders who fail to make this declaration in time will automatically be entered in the same class as indicated on the SASJ entry system.

No telephonic nominations will be accepted

The organisers request that all riders nominate their intention to scratch on any day. This assists with the smoother organisation

ALL DECLARATIONS / NOMINATIONS MUST BE MADE BY THE OWNER OR RIDER ONLY Riders are RESPONSIBLE to ensure they have the correct SASJ Rider Registration and necessary QR's to compete in a higher grade if nominating out of their grade.

PRIZEMONEY:A minimum of 60% net of entry fees less levies for classes plus sponsorship if available.All CSN Open Jumping classes will be subject to a 15% deduction from prize money to be
paid into the SASJ Riders Fund.

SUBSTITUTIONS: A substitution is a change of EITHER a horse or rider.

For National classes a substitution may only take place ONCE, before the horse inspection. Should there be NO horse inspection, a substitution may only take place ONCE, by midday on the day before the National classes start, thereafter, <u>NO</u> substitutions will be permitted. All substitutions must be given to the Show Holder on the correct forms, signed by all the correct parties.

Rider Substitutions are permitted provided the rider is registered in the correct category for the class and does not exceed more than the allowed number of horses for that class as per the rules and such is handed in 30 minutes before the start of the class.

Once a horse has been substituted, we will not accept a rider substitution on the same horse, as that constitutes a bought entry.

All substitutions must be given to the Show Secretary on the correct forms, signed by all the correct parties. Rider Substitutions are permitted provided the rider has the correct category to compete and does not exceed more than 3 horses in that class.

Substitutions of horse may not occur should the show be restricted to top ranked horses,

DRESS: Jackets Only

STABLING: R1600 per stable for the duration of the event.

Initial bedding is included. Additional bedding will be available at the show office for the competitors own account. Preference for stabling will be given to Open Horses then out of province horses.

NO TEMPORARY STABLES are to be ERECTED BY INDIVIDUALS

NO TEMPORARY PADDOCKS may be erected on the showgrounds

ALL COMPETITORS needing stabling MUST COMPLETE the STABLE BOOKING FORM and Send it to Caitlin van Niekerk: Caitlinjadevn@gmail.com

VIP MARQUEE: R1 100 Access to VIP Hall, Cocktail party and lunch Friday to Sunday.

GROOMS MEALS: R 1290 Three meals a day. Menu: View separate attachment. R600 Lunch only. Menu: View separate attachment.

There will be a covered groom's meal area with seating and a dedicated service station provided by Durban Shongweni Club at a cost of R1 290 for 3 meals per day, or R600 lunch only per person. Bookings need to be made on the Groom's Meal Booking form (available online) and sent to **shana@shongweniclub.co.za**

ACCESS: All horse boxes to enter via Kassier Road.

All horseboxes and floats must be parked in the allocated area provided.

PASSPORTS: All horses must be in possession of their FEI Passports or Group IX Passports at all shows.

Inspections, sampling and random passport checks, may take place at any event. All horses competing in FEI Classes must have FEI passports or FEI Recognition cards and must be registered with the FEI for 2019 Horse Registrations.

AHS and EQUINE FLU REGULATIONS

1 African Horse Sickness (AHS)

African Horse Sickness is a controlled disease in South Africa; therefore, any suspicion of a clinical case of AHS anywhere in the country must be reported to the local State Veterinarian immediately.

Symptoms of AHS include high temperature, rapid breathing, coughing followed by a frothy fluid from the nostrils and death within a few hours. In less acute cases, swelling of the neck and head particularly above the eyes and redness of the mucous membranes.

1 African Horse Sickness Zones

The Republic of South Africa has been divided into four zones, namely:

- 1 AHS Free Zone
- 2 AHS Surveillance Zone
- 3 AHS Protection Zone
- 4 AHS Infected Zone.

All Equines in South Africa except in the AHS Free and Surveillance Zones are required to be vaccinated against AHS annually, with an effective remedy registered in section 1, of Act 101 of 1965.

Equines residing in the AHS Free and AHS Surveillance Zones require permission from the State Directorate for vaccination against AHS.

All equines residing in the AHS Protection and Infected Zones must be vaccinated annually against AHS.

In the AHS Free, Surveillance and Protection Zone vaccination is only allowed between 1st June and 31st October of each year.

Whilst it is not a requirement that horses in the AHS Infected Zone be vaccinated between 1st June and 31st October it has been strongly recommended. Therefore, the SAEF AHS Vaccination Requirements are as follows:

1 All Equines competing in SAEF events are required to have an annual AHS vaccine with a vaccine registered under Act 101 of 1965. The vaccine consists of AHS 1 and AHS 2. The vaccine has to be administered by a registered Veterinarian, registered with the South African Veterinary Council with a minimum period of 21 days between the two vaccines.

2 The Vaccine and batch number must be written in the appropriate vaccination page and signed and stamped by the Veterinarian administering the vaccine.

3 Horses residing in the AHS Free, Surveillance and Protection Zones may only be vaccinated between 1st June and 31st of October each year.

4 Horses that reside in the AHS Free and Surveillance Zones and participate in events in these Zones only are exempt from the necessity of annual AHS vaccination. However, if they wish to compete in the AHS Protection or AHS Infected Zones, they must be vaccinated.

5 AHS vaccinations that are given with an interval of less than the minimum 21 days are null and void for both vaccinations and horses that have received such vaccinations will be deemed not to have been vaccinated.

No horse may compete for 7 days following any vaccination.

Equine Influenza (EI)

1. All Horses participating in SAEF Events must be vaccinated against Equine Influenza

2. An initial Primary Course of two vaccinations must be given; the second vaccination must be administered within 21-92 days of the first vaccination.

In completing the primary course of the vaccinations, the vaccine must be the same manufacturer for example you initially vaccinate with Proteq the second must be the same.

3. The First Booster must be given within 7 calendar months following the date of administration of the second vaccination of the primary Course.

All horses that were certified as correctly receiving the Primary Course prior to 1 January 2005 (under previous regulations), are not required to fulfill the requirement for the First Booster, providing there has been no lapse in their vaccination regime.

4. Booster Vaccinations

a) The minimum booster frequency is every 12 months.

b) However, for Horses competing, the last Booster must have been given within 6 months +21 days (and not within 7 days) before arrival at the Event.

HORSE INSPECTION: ALL 1.50 & 1.40m horses All Open Team Horses including reserve horses Tuesday 6th 2019 August9 @ 10h00

NO FURTHER HORSE INSPECTIONS will be available if you did not present your horse and want to jump in the 1.40m and 1.50m classes.

Competitors will be fined should there be any omissions or errors in the horse's passport.

MEDICATION CONTROL:

MCP testing as per SAEF Regulations will be done by the appointed Testing Vet. Laboratory: National Horse Racing Authority, Turffontein Race Course, Turf Club Street.

PROTESTS & APPEALS:

As per General Regulations. All protests and Objections must be done in writing within the required timelines and in receipt of a R750 deposit.

Rules, Regulations, Terms and Conditions applicable to all FEI, National & Provincial Classes

- Competition Classes All classes will be run under the applicable FEI Rule unless otherwise stated a deviation to the SASJ Rule.
- 2. It is the Athletes/Owners responsibility to ensure that they comply with the control measures of African Horse Sickness and Equine Flu. Batch Numbers and dates of the last two vaccinations against Equine Influenza and AHS must be stated in the passport and signed and stamped by a registered veterinarian.
- 3. Vaccinations and Micro Chip Numbers must correspond with the information loaded on the SASJ Online System
- 4. Protests lodged must adhere to the General Regulations and SASJ Rules.
- 5. Registration of Horse/Pony and Rider with their Club, SASJ and SAEF must be in order on the SASJ Database.
- 6. All Athletes and Owners should be aware of the FEI Equine Prohibited Substances list of banned Substances and Controlled Medication as well South African Drug Free Sport and WADA Regulations and prohibited substances All available on the various websites.
- 7. SASJ TAG Heuer Timing Equipment CP540 is required for all National and FEI Events and is the responsibility of the <u>OC</u> to organize, collect and return the equipment.
- 8. Athletes are to ensure that any sponsored Saddlecloths or Athlete Wear they compete in during the event that the Sponsors are registered with SASJ for the current year.
- Athletes are also to ensure their logos comply with the FEI Sizes for Advertising Article 256
- 9. Athletes are to ensure they are registered with a club, SASJ and SAEF.
- 10. PARADES Except in circumstances where special dispensation has been obtained from the Show Director, competitors must take part in any parade or display or Prize giving. Failure to do so may result in forfeiture of any Prize money, Grading/Qualification Points and/or Trophies.
- 11. The organising committee in consultation with the SASJ Representative reserves the right to combine, handicap, divide or cancel classes should this be necessary, always provided such amendments are not in conflict with the rules. Where necessary, classes may be restricted to qualifications. 80% of entry fees will be refunded should the classes be cancelled due to inclement weather conditions or unforeseen circumstances.
- 12. The FEI, SASJ, SAEF, DSC, Highway Shows and any sponsors, the Organising Committee any and/or Officials shall in no way be held responsible for any damage, loss, theft or injury sustained by owners, riders, competitors, members or the public or any other person or their property whatsoever.

- 13. N.B: The OC, Venue, FEI, SAEF, SASJ, any officials, representatives, the Organising Committee or sponsors, shall in no way be held responsible for any loss, damage, theft or injury sustained by horses, riders, appointed officials, the public or their property at the show, caused by, or resulting from this show. *E&OE*
- 14. **Changes to Classes:** The organising committee reserves the right to cancel, combine, limit, or divide classes or change arenas.

Lower grade/provincial entries may be restricted, or classes cancelled, depending on number of entries. Open grade may be restricted to 200/230 horses. Recommended rounds per day will be in consultation with the President of the Ground Jury and SASJ Rep. WE AIM TO HAVE A LIMIT OF 200/230 ENTRIES PER DAY PER ARENA. Any classes that are combined will be on a handicap basis. Changes made at/during the show will be at the SHB's discretion in consultation with the Ground Jury. This also applies to adverse weather conditions. Entry Fees will not be refunded to any competitor in the event of any competition being changed to a different time, day or different arena.

- 15. The onus is on the competitor to check the programme when it is published on the website, and to ensure that their email address is updated with the SASJ office and to check the SASJ website/newsflashes for any changes to the schedule/programme. Any changes made to the programme once the final programme is published will be published on the SASJ website www.sashowjumping.co.za or sent out via newsflash.
- 16. SAEF (Previously SAEA) General Regulations apply FEI General Regulations are applicable at FEI Events. FEI Veterinary Regulations will apply for all SASJ and FEI Events for Show Jumping in South Africa.
- 17. All stallions should have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail.
- 18. No person OR company may conduct, promote, hand out, receive items OR payment that may constitute doing any form of business during the show.
- 19. Please keep Dogs on a hand held leash at all times Failure to comply will incure a R1000 Spot fine.
- 20. Right of admission for any retailers/stall is reserved. Bookings must be made before the show.
- 21. Deduction from prize money: a DEDUCTION OF 15% will be made from all Open/CSN prize money awarded at this event. This amount will be paid to SASJ to be credited to the Showjumping Fund.
- 22. The starting order will be drawn according to FEI General Regulations.
- 23. Riders are requested to provide sleeping accommodation for their grooms as there are no facilities for this purpose. Please note that the lighting of fires or smoking in the stable areas is strictly forbidden. Kindly inform your grooms. Ablutions are available in the stable area for grooms. There are electricity outlets at the stable area.
- 24. Water is precious please be aware of water wastage and help us to conserve water where possible.
- 25. No person OR company may conduct, promote, hand out, receive items OR payment that may constitute doing any form of business during the show. Right of admission for any retailers/stalls is reserved. Bookings must be made before the show.
- 26. Temporary electronic paddocks may NOT be erected. Lunge arenas or arenas other than those demarcated for the use of the show is strictly

prohibited and will be under penalty of disqualification. The use of any area sign-posted as not demarcated for this show is also strictly prohibited. No Temporary stables are allowed to be erected on the show grounds. FAILURE TO COMPLY WILL INCUR A R1000 FINE.

- 27. PRIZE GIVING CEREMONIES: Only the top 5 prize winners will enter the arena for the prize giving.
- 28. All competitors entered are obliged to compete in all competitions for which they have qualified unless they have special dispensation from the show director. Such dispensation will normally only be given where a Veterinary or medical certificate is submitted.

Rider Substitutions are permitted provided the rider is registered in the correct category for the class and does not exceed more than the allowed number of horses for that class as per the rules and such is handed in 30 minutes before the start of the class.

Once a horse has been substituted, we will not accept a rider substitution on the same horse, as that constitutes a bought entry.

All substitutions must be given to the Show Secretary on the correct forms, signed by all the correct parties. Rider Substitutions are permitted provided the rider has the correct category to compete and does not exceed more than 3 horses in that class.

Substitutions of horse may not occur should the show be restricted to top ranked horses.

SECTION 1

SOUTH AFRICAN CHAMPIONSHIPS

1 GENERAL SOUTH AFRICAN CHAMPIONSHIP REGULATIONS

1 Status

Only the following competitions, excluding their qualifying classes, are officially recognised as South African National Show Jumping Championships and unless otherwise stated in the specific rules of each championship, must be run in accordance with this Section.

- 1.1 The Senior South African Show Jumping Championship.
- 1.2 The Junior South African Show Jumping Championship
- 1.3 The Children's South African Show Jumping Championship
- 1.4 The Pony Rider's South African Championship
- 2 Allocation

- 2.1 Each National Championship shall be staged only once in any one calendar year and shall only be staged at CSN Events.
- 2.2 All National Championships shall be allocated to Provinces by SASJ and no National Championship shall be allocated unless SASJ is satisfied that the required standards will be upheld at the event.

Application to Host

3

- 3.1 A PEXCO having been allocated a National Championship shall as soon as possible thereafter notify the SASJ National Office of proposals. Timeously completed SLA's need to be received by the 1st September each year.
 - The Name of the Event.
 - The Venue
 - The Address of the OC and Show Secretary.
 - The Dates and Length of the Event.
 - The Proposed prize money and/or other awards offered for the championship classes.
 - The position that the championship class/es would occupy on the programme.
- 3.2 SASJ in allocating each championship must ensure that the following facilities are available:

Satisfactory stabling.

- Adequate spectator and catering facilities.
- Adequate facilities for Athletes and grooms.

Adequate equipment necessary to hold competitions of S A Championship standard and to satisfy the Sponsors requirements regarding the venue, Arena Surface, choice of suitable dates, programme, presentation, organisation, production etc.

- Adequate arenas and practice areas
- 3.3 A S A National Championship shall not be advertised or staged until the OC of the event at which it is to be staged has received permission in writing from SASJ.

4 Requirements

- 4.1 Notification of date.
 - The SASJ Office shall notify Council the OC of a National Championship, of the date and duration of the Championship at least three months prior to that date, and it must be published on the National Calendar, the OC concerned shall send copies of the approved schedule to the SASJ National Office at least two months before the closing date of entries.
- 4.2 The schedule and programme/catalogue must state clearly that the championship is being staged under the authority of SASJ.

5 Eligibility of Athletes, Owners and Horses

5.1 Athletes and Owners and Horses

- 5.1.1 Eligibility of Athletes, Owners and horses as per Appendix B.
 - 5.1.2 An Athlete and Horse/Pony combination are only eligible to compete in one S A Championship title in a calendar year.

5.2 Horses

- 5.2.1 Senior S A Championships Horses must be registered with SASJ at the closing date of Entries Horses must be older than 7 years.
- 5.2.2 Junior S A Championships Horses must be registered with SASJ at the closing date of Entries Horses must be older than 7 years.
 5.2.3 Children's S A Championships
- Horses must be registered with SASJ at the closing date of Entries Horses must be older than 5 years.
- 5.2.4 Pony Championships are restricted to Ponies as per Annexure A Horses must be registered with SASJ at the closing date of Entries SASJ Ponies heights apply and must be 6 years or older.

6 Floating Trophies

- 6.1 All championship floating trophies remain the property of SASJ and shall not be handed over to the winners of a championship.
- 6.2 The OC under whose auspices a championship is staged shall be responsible for the collection from and safe return of floating trophies to SASJ, as soon as possible after the event.
- 6.3 The OC under whose auspices a championship is staged is also responsible to make good any damage to any trophy and to replace any trophy not returned to SASJ.

7 Medals

Medals shall be provided by SASJ and shall be awarded to:

Gold	First Placed Individual
Silver	Second Placed Individual
Bronze	Third Placed Individual

8 Prize Giving Protocol

The SASJ Floating Trophy, Medals and Mementos should where possible be awarded by: **Trophy** The Sponsor of the Class, or if not available,

The President of the Ground Jury

The President or Vice President of EXCO, or if not available; The Chairman of the OC, or if not available; The SASJ Representative/Technical Delegate/Member of SASJ Exco

Mementos

The sponsor of the class or if not available, The Chairman or nominee of the Organising Committee

9 Entries

10

- 9.1 Individual Championships shall not be classified as official, nor the trophies and medals awarded, unless there are at least 10 starters in each of the qualifying competitions. Application may be made to SASJ Executive to waiver this rule.
- 9.2 The OC may at their discretion allow buying and selling of entries for SA Championships up to 12H00 the day before the start of the show.
- 9.3 Substitutions of horses will not be allowed after the Veterinary Inspection has taken place.
- 9.4 Every horse presented at the Horse Inspection must have an entry for the show.
- 9.5 An entry shall be one horse and rider combination.

Order and Conditions of Classes.

- 10.1 It is compulsory for all qualifying competitions preceding a championship to be held in the order stated in the rules or schedule.
- 10.2 All National Championships shall be held in daylight, unless the night lighting provided at the venue is approved by the Technical Delegate in conjunction with the President of the Ground Jury, the OC and the Course Designer, as being of a sufficiently high standard to permit one or more of the qualifying competitions to be staged at night.

11 Order of Starting

- 11.1 In the qualifying competitions, the order of starting shall be determined in accordance with FEI Art 252.
- 11.2 In the Championship competitions the order of starting shall be in ascending order of points gained in the qualifying competitions. (Reverse order of merit).
- 11.3 Where possible a gap of at least seven horses shall be allowed between horses ridden by the same Athlete. This shall be achieved by moving that Athlete's first horse upwards in the order of riding.
- 11.4 Where there is equality of points among the horses qualified, the horses will compete in the same order relative to each other as they did in the last qualifying competition.

12 CHAMPIONSHIP CLASS

- 12.1 This competition shall be run over two rounds of a Championship course of International standard and in accordance with FEI Art 273.1, 273.2.1, 273.3.4.2, 273.4.4.
 - 12.2 Speed at 375mpm for Senior and Junior S A Championship, and 350mpm for Children's and Pony Rider. Speed may be adjusted by the President of Ground Jury in conjunction with the Course Designer to suit the arena size but may never be less than 350mpm.
 - 12.3 The first round the course will consist of between ten and twelve numbered obstacles and shall include either one double and one treble combination or three double combinations. If possible, a water jump should be included in the course but may only be included if it was included in one of the qualifying competitions.
 - 12.4 The second round shall be the same as the first round the dimensions of the fences may be altered at the discretion of the course designer.
 - 12.5 The dimensions of the fences in the jump off course may be altered at the sole discretion of the Course Designer.
 - 12.6 All rounds of Championship Class shall follow immediately one after another, however where necessary there shall be an interval of not more than fifteen minutes between the rounds.
 - 12.7 The points totals are used only to determine the order of the riding in that class. The points totals have no bearing on the scoring for the Championship Class itself unless otherwise specifically stated in the rules of a Championship.
 - 12.8 No Wild Cards/Invitational will be allowed at South African Championship events.

13 QUALIFYING SYSTEM

The qualification for the championship shall be as follows.

- 13.1. There will be 3 classes.
 - a. Welcome Stakes A 2 Competition FEI Article 238 2.1 qualifying class
 - b. Competition FEI Article 238 2.2 qualifying class.
 - c. Competition in 2 phases FEI Article 274.2 qualifying class.
- 13.2. To compete in the championship horse and athlete combinations must complete at least one of the qualifying classes.
- 13.3. The qualifying for the top 24 ranked combinations per class.
 - 13.3.1 The 8 top ranked combinations from the first class will qualify.
 - 13.3.2 The 8 top ranked combinations from the second class excluding the combinations already qualified from the first class will qualify.
 - 13.3.3 The 8 top ranked combinations from the third class excluding the combinations already qualified from the first and second class will qualify.
 - 13.3.4 In all qualifying competitions irrespective of the number of starters, the competitor placed first receives 50 points, the second receives 47 points, the third receives 45 points, and the fourth received 44 points and so on reducing by one point per place.
 - 13.3.2. In the case of ties for any place in any of the qualifying competitions, the competitors that tie shall each receive the full point's entitlement or that place that they would have received had there been no tie.
 13.3.4. Competitors who retired or are eliminated receive no points.
- 13.4. Order of Starting

In the Championship the order of starting shall be in ascending order of points gained in the qualifying competitions (Reverse order of merit).

13.5 In the case of ties for any place in any of the qualifying competitions, the horses that tie shall each receive the full points that they would have received had there been no tie

13.6 The Organising Committee is required to ensure that no more than one qualifying competition take place each day.

- 13.7 For qualifying competitions, no restriction is placed on the Organising Committee regarding -
 - 13.7.1 the number of Horses allowed to each Athlete (Maximum is 5)
 - 13.7.2 the entry fees payable.
- 13.8 The Organising Committee is required to ensure that the following words appear in the schedule and in the programme for the Events beneath the description of all qualifying competitions.

"Recognised as a qualifying competition.".

- 13.9 No Athlete is permitted to ride more than two horses in any Championship Class. In the event of an Athlete qualifying more than two horses, the Organising Committee shall, immediately the final list of qualifiers is known, obtain the Athlete's decision as to which two horses that Athlete intends to ride in the Championship Class.
- 13.10 In the event of it not being possible to determine exactly the best 24 qualified horses, due to a points total producing a tie or a late withdrawal of an Athlete, it shall be the responsibility of the PGJ and the SASJ Technical Delegate at the Event, to authorise either an increase or a decrease in the number of Athletes that may take part in the Championship Class. Under no circumstances however, shall one Athlete be permitted to ride more than two horses.
- 13.11 The Organising Committee shall ensure that a list of qualifying points of all horses, together with the order of riding for the qualified horses, is posted up or made available within one hour of the completion of the last qualifying competition.

- 13.12 In the event of a withdrawal of any of the qualified horses, additional horses may, at the sole discretion of the PGJ, be introduced in order of merit into the Championship Class to maintain the number qualified.
- 13.13 No entry, fee may be charged for the Championship Class itself. Organising Committees may however charge a starting fee. For purposes of determining of Entry Fee Levies, such starting fee shall be deemed to be an entry fee. Starting fee shall include the SASJ Levy.
- 13.14 Once the first qualifying competition of the Championship has started no substitution of Horse, is permitted for the Championship Class itself. However, in the qualifying competitions themselves, as individual competitions, substitutions of rider will be permitted.
- 13.15 SASJ Electronic Timing, approved by EXCO, incorporating a displayed countdown facility, is obligatory for all qualifying classes and the Championship Class.
- 13.16 No Wild cards for any S A National Championships will be permitted.

14 PRIZES, TROPHIES AND MEDALS

- 14.1. There shall not be fewer than three prizes for the Championship Class, and the first prize shall not be less than 33% of the total prize money for the Championship Class.
- 14.2 SASJ will award a floating trophy and a gold medal to the winner of each Championship, silver and Bronze medals for second and third.
- 14.3 On <u>prior written</u> application by a SASJ, The EXCO may grant permission for this regulation. To be varied. Such variation may only be granted for CSN Events and must be stipulated in the schedule.

15 JUDGES

Championship Classes and their qualifying classes shall be judged by a Ground Jury as set out in Annexure Officials. Should the OC be unable to comply with this rule, they may apply to SASJ National for dispensation.

16 HORSE INSPECTIONS

- 16.1 Horse inspections are compulsory at all Championships. These inspections must be conducted in accordance with these Rules. or, in their absence, the FEI Veterinary Regulations.
- 16.2 The costs incurred in holding horse inspections shall be for the account of the OC.
- 16.3 Every horse presented must have a valid passport and valid entry per horse.
- 16.4 No Substitutions of horse may take place after the vet inspection.

SECTION 6 NATIONAL TEAM CHAMPIONSHIPS

1 Eligibility of Athletes

Athletes must have been normally resident within the Republic for a period of twelve consecutive months or more, immediately preceding the closing date for entries, and must have their principal place of residence in the Province which they are representing, as at the closing date of entries.

2 Intention to Compete

- 1 Provincial SJ Committees wishing to enter in National Team Championships shall notify the National SASJ Office and OC of the event in writing of their intention to participate, before the closing date for entries.
- 2 Each Provincial SJ Committee may only enter one team

3 Nominations

- PEXCOs shall submit details of their team, in writing, to the CEO and to the OC of the event, not later than seven clear days before the first competition day of the event.
 Horses and Athletes nominated in terms of this regulation must already have been
- 2 Horses and Athletes nominated in terms of this regulation must already have been entered for at least one individual class at the event before the closing date for entries.
- 3 The nominations shall state the first and last names of the athletes and the names of the horses together with the name of the Chef d'Equipe. Nominations will not be accepted unless the name of the Chef d'Equipe is included. The Chef d'Equipe shall also act to be the Team Captain.
- 4 The total number of nominations allowed is as follows:

SJ Committee of the Province concerned as being correct and in accordance with the rules.

4 **Final Selection**

- The final selection of the Team shall be submitted by the Chef d'Equipe to the OC of the 1 event and to the Technical Delegate by not later than 17h00, or such other time as the Technical Delegate may determine, on the day immediately prior to the Competition.
- 2 The Technical Delegate shall then, in the presence of the Chefs d'Equipe and the OC draw the order of starting of teams.
- 3 The selected team shall be chosen from those Athletes and horses nominated in terms of SASJ Requirements and regulations.
- 4 The following details shall be submitted together with the Final Selection: Selected Horse and Athlete combination (4) Reserve Athlete (1) Reserve Horses (2) Order of riding of horses 5 Should a team at the time of selection only be able to produce three Horse and Athlete combinations, then
- that team shall compete with only three Horse and Athlete combinations. 6
- Reserves
 - The Athlete and Horses nominated in terms of these regulations, but not included in the final selection are in fact the reserves.
- There may be no substitutions of riders or horses after the nominations have been submitted. 7

5 National Team Events

- Each National Championship shall be staged only once in any one calendar year and shall only be staged at CSN Events.
- Adult S A National Team Event @ 1.35 Level *
- * Junior S A National Team Event @ 1.30 Level
- * Children S A National Team Event @ 1.10 Level
- * Pony Rider S A Team Event @ 1.10 level

Open Team Medals shall be awarded a follows:

Gold to winning Team

Silver to Second place Team

Bronze to third placed Team

Reserves shall be awarded a medal if their team is placed

6 Rules

FEI Art 273 – 2 Round Competition Rule

- This competition shall be run over two rounds of a Championship course of national standard and in 1 accordance with FEI Art 273.3.3.2. Speed 350mpm.
- The course will consist of between ten and twelve numbered obstacles and shall include either one double 2 and one treble combination or three double combinations. If possible a water jump should be included in the course but may only be included if it was included in one of the qualifying competitions.
- 3 The course for the second round shall be a shortened course and shall include one double combination
- 4 The order of starting for the second round of the Championship shall be on the basis of reverse order of merit of each team from the first round.
- The second round shall be against the clock. 5
- 6 There be no jump-off.

7 Classification

Classification of the class will be the 3 best scores each team from the first round the then the 3 best combination scores from the second round. First round penalties only, second round penalties and time.



1 THE SERIES

The 2019 SA Show Jumping U25 Series is a new exciting series in South Africa for our top an upcoming young rider up to the age of U25.

The Proposed classes will be:

Leg 1: President's Cup – Leg 1- Maple Ridge Equestrian Farm sponsored by Mac Mobile
Leg 2: CSI-W Shongweni – Leg 2 sponsored by Spec Con
Leg 3: SA Adult Champs – leg 3 sponsored by The Fat Fish

Leg 3: SA Adult Champs – leg 3 sponsored by The Fi

Other legs to be confirmed.

All classes in the series together with their preliminary classes will carry CSN Status and will be judged under Table A.

2 QUALIFICATION OF RIDERS

The Series is restricted to riders from the year they turn 16 years of age to the end of the year they turn 25.

3 QUALIFICATION OF HORSES

Open to all horses from the age of 7.

4 PRELIMINARY COMPETITIONS PRIOR TO EACH SERIES COMPETITION

At each event the Organising Committee shall include in the schedule at least one preliminary competition for Open horses at 1,35m or 1,40m, competing separately.

5 ORDER OF STARTING

- 5.1 The order of starting in all the legs of the competitions shall be drawn.
- 5.2 Where possible, a gap of at least seven horses shall be allowed between horses ridden by the same rider. This shall be achieved by moving that rider's first horse drawn upwards in the order of riding.
- 5.3 Should a rider have more than one horse entered in any of the series competitions, then that rider shall declare, prior to the commencement of the class, which horse will be going for the series points and that horse must be ridden first as per World Cup Rules.

6.45 Rules

- All series competitions will be run over Championship courses of National Standard (1,35m with some fences at 1.40m) run at a speed of 350 mpm.
- Preliminary classes at each event will be run at a speed of 350mpm, or the speed of the relevant competitions at the show.

7 ELIGIBILITY

All competitions are open to all Juniors and Young Riders qualified to compete in Open Classes provided they have the necessary QR's and Age Category.

8 POINTS

Points will be awarded to riders in accordance with the FEI World Cup Qualification points system as set out in 10 below.

9 CLASSIFICATION

Should there be a tie for first place overall after completion of the series, the highest placed competitor in the final competition will be declared the Series winner.
