CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in International Equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses' welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health, before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the Event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper Veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

RESTRICTIONS: **Heartland Riders Grand Prix classes, a competitor may only ride 3 – three horses.**
A horse may only compete in one class per day (National) and two classes per day (Provincial) with a maximum of 3 classes at the event (excluding orientation and training classes).
Should your entry be deleted for non-payment, the entry will not be restored based on when it was initially done but will be based on when it was paid for thus if the arenas are full, it will be added to the waiting list.

NOMINATIONS: Declarations/Nominations for classes (1.30m - 1.45m) taking place on the first day must be done online on the riders' profile via nomination system by no later than 12h00 on Thursday 18th May 2023
Riders who fail to make this declaration in time will automatically be entered in the same class as indicated on the SASJ Entry system.

Declarations will close 30 min after the end of the last open class on each day.
Riders who fail to make this declaration in time will automatically be entered in the same class as indicated entered on the SASJ entry system.

NOMINATIONS ARE ALL DONE ON THE SASJ ONLINE SYSTEM - DECLARATIONS / NOMINATIONS MUST BE MADE BY THE OWNER OR RIDER ONLY ON THE SYSTEM. NO EMAIL / TELEPHONIC / WHATSAPP / SMS nominations will be accepted.

SASJ RISING STAR SERIES: Should a rider have more than one horse entered in any of the series competitions, then that rider shall declare, prior to the commencement of the class, which horse will be going for the series points and that horse must be ridden first in all the competitions. Declarations must be made 30 minutes after the last open class on Saturday 20th May 2023.

STARTING FEES: Payable before the start of **Class 2.4** **U25 CSI-U25A** **18CHF FEI MCP per horse plus security and other fees to be published once entries close.**

QUALIFICATIONS: N/A

PRIZEMONEY: A minimum of 60% net of entry fees less levies for CSN classes plus sponsorship and 40% less levies Provincial classes plus sponsorship per class if available. This excludes sponsorship money that will be independently allocated by the OC. **All CSN Jumping classes will be subject to a 15% deduction from prize money to be paid into the SASJ Riders Fund.**
Recreational classes: Rosettes only & sponsored prizes if available.

SUBSTITUTIONS: A substitution is a change of EITHER a horse or rider.
For provincial classes with a Composite entry fee: should a horse need to be substituted it may be substituted ONCE per entry only. Should a rider need to be substituted and the entry consists of a composite entry of 4 classes, the rider may be changed more than once. All substitutions must be given to the show holder on the correct forms, signed by all the correct parties, a minimum of 30 minutes before the start of the relevant class.
For National classes, a substitution may only take place ONCE, before the horse inspection. Should there be NO horse inspection; a substitution may only take place ONCE, by midday on the day before the National classes start, thereafter, and NO

substitutions will be permitted. All substitutions must be given to the Show Holder on the correct forms, signed by all the correct parties.

DRESS: All items of dress used must align with the Jumping Rules Art. 256.1.5, Annex XI – Art. 19, Annex XII – Art. 17

STABLING: **R800 for the duration of the show.** Stabling is limited and will be booked on a first come first serve basis, should you require to be stabled together with another rider please send the booking forms together as stabling is allocated immediately upon receipt. Initial bedding will be provided.

NO PADDOCKS TO BE ERRECTED AT THE VENUE

ALL COMPETITORS needing stabling MUST COMPLETE the Stable booking form and submit the booking prior to arriving at the show.

Initial Bedding will be provided, additional bedding will be available to purchase at R25.00 per bag.

The allocation of stabling accommodation is carried out by the Show Director and under no circumstances may any competitor change his/her stabling accommodation or alter the stabling list without prior consultation with, and approval of, the Show director.

Failure to comply could involve disqualification of the horse concerned.

Stables will be allocated to out of Province rider first, on a first come, first paid basis.

Competitors wishing to be stabled with others should indicate this on their stable booking form, however, please bear in mind that if the person you are wanting to be stabled with has booked early and you have booked late or vice versa this allocation may not be possible as stables are allocated strictly on a first booked and paid for basis.

The grooms are encouraged to hand walk horses.

AHS and EQUINE FLU REGULATIONS

1 African Horse Sickness (AHS)

African Horse Sickness is a controlled disease in South Africa; therefore, any suspicion of a clinical case of AHS anywhere in the country must be reported to the local State Veterinarian immediately.

Symptoms of AHS include high temperature, rapid breathing, coughing followed by a frothy fluid from the nostrils and death within a few hours. In less acute cases, swelling of the neck and head particularly above the eyes and redness of the mucous membranes.

1 African Horse Sickness Zones

The Republic of South Africa has been divided into four zones, namely:

- 1 AHS Free Zone
- 2 AHS Surveillance Zone
- 3 AHS Protection Zone
- 4 AHS Infected Zone.

All Equines in South Africa except in the AHS Free and Surveillance Zones are required to be vaccinated against AHS annually, with an effective remedy registered in section 1, of Act 101 of 1965.

Equines residing in the AHS Free and AHS Surveillance Zones require permission from the State Directorate for vaccination against AHS.

All equines residing in the AHS Protection and Infected Zones must be vaccinated annually against AHS.

In the AHS Free, Surveillance and Protection Zone vaccination is only allowed between 1st June and 31st October of each year.

Whilst it is not a requirement that horses in the AHS Infected Zone be vaccinated between 1st June and 31st October it has been strongly recommended.

Therefore, the SAEF AHS Vaccination Requirements are as follows:

- 1 All Equines competing in SAEF events are required to have an annual AHS vaccine with a vaccine registered under Act 101 of 1965. The vaccine consists of AHS 1 and AHS 2. The vaccine has to be administered by a registered Veterinarian, registered with the South African Veterinary Council with a minimum period of 21 days between the two vaccines.
- 2 The Vaccine and batch number must be written in the appropriate vaccination page and signed and stamped by the Veterinarian administering the vaccine.
- 3 Horses residing in the AHS Free, Surveillance and Protection Zones may only be vaccinated between 1st June and 31st of October each year.
- 4 Horses that reside in the AHS Free and Surveillance Zones and participate in events in these Zones only are exempt from the necessity of annual AHS vaccination. However, if they wish to compete in the AHS Protection or AHS Infected Zones, they must be vaccinated.
- 5 AHS vaccinations that are given with an interval of less than the minimum 21 days are null and void for both vaccinations and horses that have received such vaccinations will be deemed not to have been vaccinated.

No horse may compete for 7 days following any vaccination.

Equine Influenza (EI)

1. All Horses participating in SAEF Events must be vaccinated against Equine Influenza
2. An initial Primary Course of two vaccinations must be given; the second vaccination must be administered within 21-92 days of the first vaccination.

In completing the primary course of the vaccinations, the vaccine must be the same manufacturer for example you initially vaccinate with Proteq the second must be the same.

3. The First Booster must be given within 7 calendar months following the date of administration of the second vaccination of the primary Course.

All horses that were certified as correctly receiving the Primary Course prior to 1 January 2005 (under previous regulations), are not required to fulfill the requirement for the First Booster, providing there has been no lapse in their vaccination regime.

4. Booster Vaccinations

- a) The minimum booster frequency is every 12 months.
- b) However, for Horses competing, the last Booster must have been given within 6 months +21 days (and not within 7 days) before arrival at the Event.

Equine Influenza Vaccination Requirements

Vaccination	Protocol	Eligibility to Enter Venue
Primary Course	I. 1st Vaccination: day II. 2nd Vaccination: day 21-92	Horses that have only received the first vaccination of the primary course are not allowed to compete or enter the FEI stables. Horses that have received the primary course can compete provided that the vaccine has not been given within 7 days of arriving at an event venue
First Booster	Within 7 months of the 2nd vaccination of the Primary Course	Horses must have been vaccinated to comply with the requirements for the Primary Course Horses that received their primary course before 2005 are exempt from the first booster requirement within 7 months. Subsequent boosters are to be given at intervals of no later than 1 calendar year after the primary course. Horses can compete for up to 6 months +21 days after the 2nd vaccination of the Primary Course, however they cannot compete if they have been vaccinated within 7 days of arriving at an event venue. (e.g., may enter venue after 8 October 2014).
Subsequent Boosters	III. MINIMUM: within one year of previous booster vaccination. COMPETING: must usually be in the 6 months +21 days of previous booster vaccination.	Horses must have been vaccinated to comply with the requirements for the Primary Course, First Booster, and all subsequent boosters. Horses must have been vaccinated within 6 months +21 days of arriving at the Event however they cannot compete if they have been vaccinated within 7 days of arriving at an event venue.

HORSE INSPECTION : Sunday 21st May 2023 08h00

For horses competing in the U25 SASJ Rising Star Championship 1.35m CSI1* class, Junior SASJ Rising Star Series and Pony Rider Rising Star Series.

Competitors will be fined should there be any omissions or errors in the horse's passport.

MEDICATION CONTROL:

MCP testing as per SAEF Regulations will be done by the appointed Testing Vet.
Laboratory: National Horse Racing Authority, Turffontein Racecourse, Turf Club Street.

PROTESTS & APPEALS:

As per General Regulations. All protests and Objections must be done in writing within the required timelines and in receipt of a R750 deposit.

Rules, Regulations, Terms and Conditions **applicable to all FEI, National & Provincial Classes**

1. Competition Classes – All classes will be run under the applicable FEI Rule – unless otherwise stated a deviation to the SASJ Rule.
2. Abuse of the horse will be strictly prohibited and observed.
3. It is the Athletes/Owners responsibility to ensure that they comply with the control measures of African Horse Sickness and Equine Flu. Batch Numbers and dates of the last two vaccinations against Equine Influenza and AHS must be stated in the passport and signed and stamped by a registered veterinarian.
4. Vaccinations and Micro Chip Numbers must correspond with the information loaded on the SASJ Online System
5. Protests lodged must adhere to the General Regulations and SASJ Rules.
6. Registration of Horse/Pony and Rider with their Club, SASJ and SAEF must be in order on the SASJ Database.
7. All Athletes and Owners should be aware of the FEI Equine Prohibited Substances list of banned Substances and Controlled Medication as well South African Drug Free Sport and WADA Regulations and prohibited substances – All available on the various websites.
8. Unpaid entries will not be deleted or refunded after closing date and are due and payable.
9. Entries will not be refunded if withdrawn after clothing date of entries. Entries may be bought and sold.
10. SASJ National Timing Equipment – is required for all National and FEI Events and is the responsibility of the OC to organize, collect and return the equipment.
11. Athletes are to ensure that any sponsored Saddlecloths or Athlete Wear they compete in during the event – that the Sponsors are registered with SASJ for the current year. Athletes are also to ensure their logos comply with the FEI Sizes for Advertising – Article 256
12. Athletes are to ensure they are registered with a club, SASJ and SAEF.
13. PARADES - Except in circumstances where special dispensation has been obtained from the Show Director, competitors must take part in any parade or display or Prize giving. Failure to do so may result in forfeiture of any Prize money, Grading/Qualification Points and/or Trophies.
14. The organising committee in consultation with the SASJ Representative reserves the right to combine, handicap, divide or cancel classes should this be necessary, always provided such amendments are not in conflict with the rules. Where necessary, classes may be restricted to qualifications. 80% of entry fees will be refunded should the classes be cancelled due to inclement weather conditions or unforeseen circumstances.
15. The FEI, SASJ, SAEF, Heartland Equestrian Park, SANEC and any sponsors, the Organising Committee any and/or Officials shall in no way be held responsible for any damage, loss, theft or injury sustained by owners, riders, competitors, members or the public or any other person or their property whatsoever.
16. N.B: The OC, Venue, FEI, SAEF, SASJ, any officials, representatives, the Organising Committee or sponsors, shall in no way be held responsible for any loss, damage, theft or injury sustained by horses, riders, appointed officials, the public or their property at the show, caused by, or resulting from this show. E&OE
17. Changes to Classes: The organising committee reserves the right to cancel, combine, limit, or divide classes or change arenas. Lower grade/provincial entries may be restricted, or classes cancelled, depending on number of entries. Open grade may be restricted to 220 horses. Recommended rounds per day will be in consultation with the President of the Ground Jury and SASJ Rep. WE AIM TO HAVE A LIMIT OF 220 ENTRIES PER DAY PER ARENA. Any classes that are combined will be on a handicap basis. The organising committee in consultation with the SASJ Representative reserves the right to combine, handicap, divide or cancel classes should this be necessary, always provided such amendments are not in conflict with the rules. Where 7 necessary, classes may

be restricted to qualifications. 80% of entry fees will be refunded should the classes be cancelled due to inclement weather conditions or unforeseen circumstances.

18. The onus is on the competitor to check the programme when it is published on the website, and to ensure that their email address is updated with the SASJ office and to check the SASJ website/newsflashes for any changes to the schedule/programme. Any changes made to the programme once the final programme is published will be published on the SASJ website www.sashowjumping.co.za or sent out via newsflash.
19. SAEF (Previously SAEA) General Regulations apply – FEI General Regulations are applicable at FEI Events. FEI Veterinary Regulations will apply for all SASJ and FEI Events for Show Jumping in South Africa.
20. All stallions should have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail.
21. Competition stallions remain the responsibility of the owner & rider at all times & they are expected to have public liability against any loss, injury or damage that might be caused by the stallion.
22. Please always keep your dogs on a handheld leash – Failure to comply will incur a R1000 Spot fine.
23. Deduction from prize money: a DEDUCTION OF 15% will be made from all Open/CSN prize money awarded at this event. This amount will be paid to SASJ to be credited to the Showjumping Fund.
24. The starting order will be drawn according to FEI General Regulations.
25. Riders are requested to provide sleeping accommodation for their grooms as there are no facilities for this purpose. Please note that the lighting of fires or smoking in the stable areas is strictly forbidden. Kindly inform your grooms. Ablutions are available in the stable area for grooms. There are electricity outlets at the stable area.
26. Water is precious – please be aware of water wastage and help us to conserve water where possible.
27. No person OR company may conduct, promote, hand out, receive items OR payment that may constitute doing any form of business during the show. Right of admission for any retailers/stalls is reserved. Bookings must be made before the show.
28. No temporary electronic paddocks may be erected as there is limited parking space, FAILURE TO COMPLY WILL INCUR A R1000 FINE. Please use the Lunge arenas to lunge horses. Use of arenas other than those demarcated for the use of the show is strictly prohibited and will be under penalty of disqualification. The use of any area sign posted as not demarcated for this show is also strictly prohibited.
29. PRIZE GIVING CEREMONIES: Only the top 6 prize winners will enter the arena for the prize giving.
30. All competitors entered are obliged to compete in all competitions for which they have qualified unless they have special dispensation from the show director. Such dispensation will normally only be given where a Veterinary or medical certificate is submitted.
31. No un-invited photographers, please make use of the show photographers.

By entering this show online, I hereby confirm, as a member or temporary member, that I will not hold Highway Shows, SASJ, NWHS, SAEF nor their officials responsible for any loss, damage, theft or injury to any person, animal or property or anything appertaining to the show.

2.2.1 Height – First Round Grand Prix Type course at 1.40m with 4 fences at 1.45m

3. DESCRIPTION OF THE RULES

The competition will be run over 2 rounds. Both rounds against the clock.

At least 25% return for the second round, based on their penalties and time in the first round; in any case all Athletes without penalties in the first round, return for the second round.

Starting order of the second round shall be reverse order of penalties and time in the first round, an Athletes retain their draw order in case of equality of penalties and time.

Athletes will be placed according to aggregate Penalties over both rounds and the time incurred in the second round. Athletes not taking part in the second round will be placed according to the Penalties incurred in the first round according to their Penalties and time in the first round.

Section 9 - SASJ RISING STAR SERIES

1. THE SERIES

The SA Show Jumping Rising Star Series is a series in South Africa for our top and upcoming Young Riders, Junior, and Pony Riders.

The Final Series class will carry CSN Status.

2. QUALIFICATION OF RIDERS

2.1 U25

The Series is a special class restricted to riders from the beginning of year they turn sixteen years of age to the end of the year they turn twenty-five.

2.2 JUNIOR

The Series is a special class restricted to riders from the beginning of year they turn twelve years of age to the end of the year they turn eighteen.

2.3 PONY RIDER

The Series is a special class restricted to riders competing on ponies up to the end of the year the rider turns sixteen as per SASJ Annexure A and B

3 QUALIFICATION OF HORSES

Open to all horses/Ponies from the age of seven.

4 PRELIMINARY COMPETITIONS PRIOR TO EACH SERIES COMPETITION

At each event, the Organising Committee shall include in the schedule at least one preliminary competition for Open horses/Ponies.

5 ORDER OF STARTING

5.1 The order of starting in all the legs of the competitions shall be drawn.

5.2 Where possible, a gap of at least ten horses shall be allowed between horses ridden by the same rider. This shall be achieved by moving that rider's first horse drawn upwards in the order of riding.

5.3 Should a rider have more than one horse entered in any of the series competitions, then that rider shall declare, prior to the commencement of the class, which horse will be going for the series points and that horse must be ridden first in all the competitions.

6 RULES

6.1 U25

All series competitions will be run over Championship courses of National Standard (1,35m with some fences at 1.40m) run at a speed of 375 mpm.

Preliminary classes at each event will be run at a speed of 375mpm, or the speed of the relevant competitions at the show.

The qualifying rounds will be run under **FEI Art 238.2.2.**

The Final competition will be run under **FEI Art 273.2.2.2 ii, 273.3.3.2., Art 273.4.3**

6.2 JUNIOR

All series competitions will be run over Championship courses of National Standard (1,30m with SASJ Section 9 some fences at 1.35m) run at a speed of 375 mpm.

Preliminary classes at each event will be run at a speed of 375mpm, or the speed of the relevant competitions at the show.

The qualifying rounds will be run under **FEI Art 238.2.2.**

The Final competition will be run under **FEI Art 273.2.2.2 ii, 273.3.3.2., Art 273.4.3**

6.3 PONY RIDER

All series competitions will be run over Championship courses of National Standard (1,10m with some fences at 1.15m) run at a speed of 350 mpm.

Preliminary classes at each event will be run at a speed of 350mpm, or the speed of the relevant competitions at the show.

The qualifying rounds will be run under **FEI Art 238.2.2.**

The Final competition will be run under **FEI Art 273.2.2.2 ii, 273.3.3.2., Art 273.4.3**

7 ELIGIBILITY

All competitions are open to all riders and Horses/Ponies as per Annexure A and B Riders qualified to compete in Open Classes provided, they have the necessary QR's and Age Category.

8 POINTS

Points will be awarded to riders in accordance with the Qualification points system as set out in 10 below.

Points for the series will be calculated from the best of 2 (two) Qualifiers and the Final Qualifier to obtain the Series final overall results.

9 CLASSIFICATION

Should there be a tie for first place overall after completion of the series, the highest placed competitor in the final competition will be declared the Series winner.
