HEADS OF AGREEMENT

Between

SOUTH AFRICAN NATIONAL EQUESTRIAN SCHOOLS ASSOCIATION ("SANESA")

and

SA SHOW JUMPING ("SASJ")

PREAMBLE:

In the interest of re-establishing a positive and mutually beneficial relationship between SANESA and SASJ, and in the interest of developing the discipline of Jumping within the SANESA Inter-schools Equestrian League, the parties agree that they will enter into a Co-Operation Agreement with one another, to be agreed and finalised between the parties, which shall include but not be limited to the following terms:

TERMS TO BE INCLUDED:

- 1. SASJ shall recognise and award qualification points in respect of all SANESA Jumping classes, subject to the following:
 - 1.1 any SANESA rider requiring qualification points shall be registered with South Africa Show Jumping ("SASJ"), as per SASJ's requirements;
 - 1.2 the horse or pony upon which the rider wishes to obtain qualification points must, likewise, be correctly registered with SASJ;
 - 1.3 the venue at which SANESA holds its shows, and for which the rider is seeking qualification points, must be an approved venue in terms of SASJ's requirements;
 - 1.4 the judges judging any such classes shall be properly qualified in terms of SASJ's requirements to judge at the requisite level;
 - 1.5 The courses ridden shall be the current SASJ standard as applicable at the time. The course designer shall be properly qualified in terms of SASJ's requirements.
- 2. The Rider shall only qualify for qualification points at the level and on the horse for which they are appropriately registered with SASJ;
- In the event that a venue is not approved by SASJ, SANESA shall work together with SASJ and the venue owners to achieve the necessary approvals;
- The SANESA Rider shall be required to register on the SANESA system with his/her SASJ Registration Number, and when entering a show shall select the option for qualification points;



- Provided the SANESA show meets the requirements as set out above, and the Rider has registered correctly, SASJ shall grant the appropriate qualification points to the rider upon completion of the relevant class, upon the recording of the relevant results for the class.
- 6. SANESA shall, upon the Rider's entry for the class, and selection for qualification points, collect the requisite qualification levy, which shall be set and agreed in the agreement to be finalised, subject to an annual increase to be determined by the parties hereto, which SANESA shall pay across to SASJ by no later than the last working day of the month immediately following the date in which the show is held to SASJ, into the bank account as nominated by them, which shall be set out in the co-operation agreement.
- 7. In order for the qualification points to be issued to the rider, SANESA shall present SASJ with the relevant score sheets in an electronic format with proof of the original duly signed by the presiding judge, as evidence of the results of the class, for the purposes of the issuing of the qualification points. Should the judge deem the class was not up to the required standard they can withhold the qualification points.
- 8. In the event that the rider fails to pay the requisite qualification levy to SANESA, then SANESA shall advise SASJ accordingly, and the qualification points shall be withheld until such time as the payment is made and the qualification points are allocated.
- 9. SASJ undertakes to allocate the qualification points immediately upon receipt of payment of the qualification levy in respect of the rider, and in any event not more than 7 (seven) days thereafter.
- 10. SASJ and SANESA shall agree on the acceptable dispensations to be granted for all SANESA classes, to accommodate school specific issues such as dress code (to allow for school colours), numnahs (to allow for school colours), it being specifically recorded that issues such as horse equipment such as bits, whips etc. will not be changed.
- SANESA shall work together with SASJ, in order to provide the opportunity for Jumping judges and officials to train and develop their skills within the SANESA environment.
- 12. SANESA shall provide the opportunity to, within the constraints of the SANESA Constitution, to provide SASJ with the opportunity of marketing SASJ to its riders, in order to promote the discipline of Jumping within the SANESA structures.

13. SANESA and SASJ shall attempt to broaden this agreement throughout all of the Provinces in South Africa, together with SASJ, to the extent possible.
